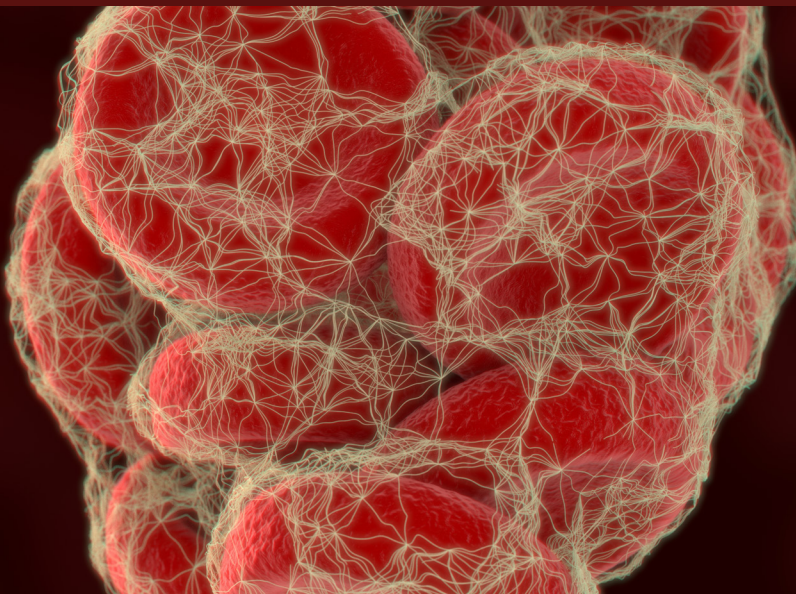

## COURSE DESCRIPTION

***Clinical Practice Updates in Hemostasis and Thrombosis*** is designed to provide practitioners with information on the diagnosis and management of inherited and acquired hemostatic and thrombotic disorders along with new medication updates.

## TARGET AUDIENCE

This educational activity targets practicing hematologists/oncologists who diagnose and treat patients with congenital and acquired hemostatic and thrombotic disorders as well as interested internists.

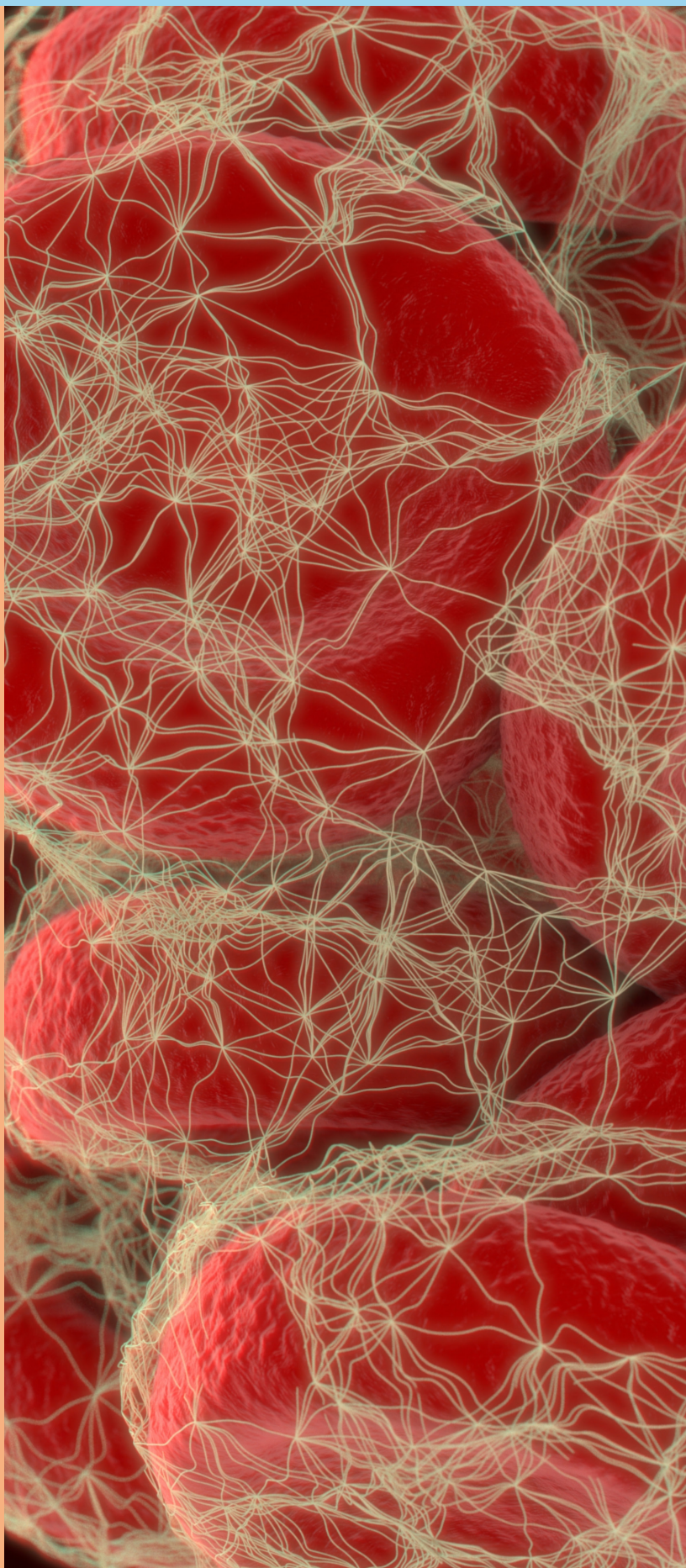
